Solicitors Application

REQUIREMENTS

Identification Card Required

All persons engaging in business as a solicitor shall be required to obtain an identification card from the City. The identification card shall be attached to the clothing at all times while engaging in the business within the City. There is a FIVE DOLLAR (\$5.00) non-waivable fee for each identification card issued by the City.

2. Application Fee

Every person seeking to conduct a business as a r solicitor shall file an application for an identification card from the City and submit an application to the Police Department. Any person or group issued a solicitor's permit under the provisions of this section shall pay a FIFTY DOLLAR (\$50.00) fee (\$25.00 fee after April 1). All solicitors' permits are valid for ONE YEAR starting at the beginning of the fiscal year. All permit fees (including security deposits) shall be waived if said organization shows proof of non-profit status.

3. Hours of Operation

A person or group issued a city solicitor's permit may solicit from the public only from 8:00 am to 9:00 pm, Monday through Friday, and from 9:00 am to 9:00 pm Saturday and Sunday. Violation of this requirement will result in immediate revocation of the solicitor's permit and issuance of a citation.

4. Location

It shall be unlawful for any solicitor to do business, except for city sponsored functions, within THREE HUNDRED (300) feet of any property used, owned, or operated for public or private school purposes, religious centers, or government buildings. This restriction shall include streets, sidewalks, and other public property and rights-of-way in the prohibited area.

Entrance to Premises Restricted

It shall be unlawful for any solicitor to enter upon any private property when the same is posted with a sign stating "no peddlers allowed" or "no solicitors" or other words to that effect.
